#### **Description of Services**

County Service Area 38 was originally authorized by LAFCO Resolution No. 603 in 1983. Its purpose was to provide "extended police protection." In the jargon of the day, "extended police protection" meant services that were only provided outside incorporated cities. The common service in this category was sheriff's patrol. The cities were paying for city police patrol out of their municipal budgets, and they wanted the county to account for certain revenues that supported a service that the cities did not benefit from. CSA 38 was set up, and now demonstrates that property taxes derived solely from unincorporated areas flow through to the sheriff's patrol.

The CSA 38 boundary encompasses all areas of Santa Cruz County outside incorporated cities. As territory is annexed to cities, it is simultaneously detached from CSA 38. CSA 38 revenues provide approximately 3% of the total budget of the Sheriff's Department and 6% of the Operations Bureau budget.

LAFCO adopted the first Sphere of Influence for CSA 38 by Resolution No. 698-C in 1985. The geographical area of the Sphere includes all the territory with the County, including the cities. The rationale for including the cities in the sphere was that, if a city wanted to contract with the sheriff's office for patrol services, it would be able to annex to CSA 38 and set up a zone of CSA 38 to direct payments for this service. No city has chosen to exercise this option.

Court Security provides security to courts in Santa Cruz and Watsonville. CSA #38 revenues represent 6% of the Operations Division's expenditures.

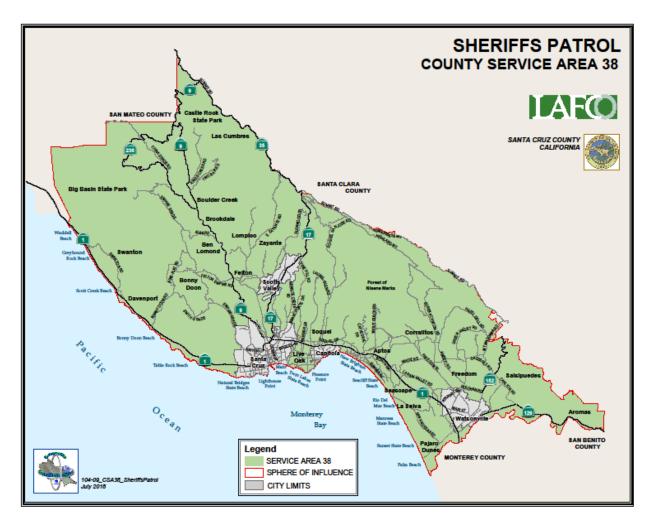
