Dear Santa Cruz County LAFCO,

I have read the proposed Resolution 2023-021 and found incorrect information:

1) LAFCO denied my Request for Reconsideration at the September 6, 2023 meeting, not September 4.

"WHEREAS, a 30-day request for reconsideration period was held during August 3 to September 1, 2023, in accordance with Government Code Section 56895. LAFCO did receive a request to reconsider the Commission's approval during this period. The Commission, legal counsel, and staff determined during the September 4, 2023 LAFCO Meeting that the request did not meet the criteria under Government Code Section 56895; and"

I request that the Commission request the Executive Officer date be corrected to reflect the actual LAFCO meeting date of September 6, 2023.

2) It appears that LAFCO Executive Director did not provide published notice of the September 27, 2023 Protest Hearing, as is required by Govt. Code 56153 and 56154, following requirements of Govt. Code 6061 for one-time publishing in a local newspaper at least 21 days in advance of the hearing. LAFCO staff has not provided any such responsive materials to my Public Records Act request for such. LAFCO staff has also not provided any such responsive materials to my Public Records Act request for published notice in a newspaper of the August 2, 2023 LAFCO public hearing for the Branciforte Fire District Reorganization.

"WHEREAS, on September 1, 2023, LAFCO provided notice of the protest proceeding in accordance with Government Code Section 57025. A 24-day protest period was conducted during September 4 to September 27, 2023; "

I request that proper noticing, published in a local newspaper occur, in compliance with the Govt. Codes applicable, and that the related hearings and actions be taken be re-done in order to be compliant with the laws of California.

Govt. Code 57025:

- (a) The executive officer of the commission shall give notice of the protest hearing to be held on the proposal by publication pursuant to <u>Sections 56153</u> and <u>56154</u> and by posting pursuant to <u>Sections 56158</u> and <u>56159</u>.
- (b) The executive officer shall give mailed notice to all landowners owning land within any affected territory, consistent with <u>Sections 56155</u> to <u>56157</u>, inclusive.
- (c) If the affected territory is inhabited, the executive officer shall also give mailed notice to all registered voters residing within any affected territory, consistent with <u>Sections 56155</u> to <u>56157</u>, inclusive.

- (d) The executive officer shall also give mailed notice to each affected city, affected district, or affected county, the proponents, if any, and to persons requesting special notice, consistent with Sections 56155 to 56157, inclusive.
- (e) In the case of a proposed change of organization or reorganization that would result in the extension of any previously authorized special tax or benefit assessment to the affected territory, the executive officer of the commission shall give mailed notice to each landowner within the affected territory.

Govt. Code Section 56153:

Notice required to be published shall be published pursuant to <u>Section 6061</u> in one or more newspapers of general circulation within each affected county, affected city, or affected district. If any newspaper is a newspaper of general circulation in two or more affected cities or affected districts, publication in that newspaper shall be sufficient publication for all those affected cities or affected districts. If there are two or more affected counties, publication shall be made in at least one newspaper of general circulation in each of the affected counties.

Govt. Code 6061:

Next »

Publication of notice pursuant to this section shall be for one time.

Govt. Code Section 56154:

If the published notice is a notice of a hearing, publication of the notice shall be commenced at least 21 days prior to the date specified in the notice for the hearing.

- 3) Request for Clarification: I still have concern that areas formerly included in the Branciforte Fire District have not been included in the Successor Agency map. Please compare the area at the far bottom right of the boundary maps on pages 3 and 4 of the Resolution. LAFCO did not address this concern on September 6, 2023 during deliberation of my Request for Reconsideration, referencing it as a possible island.
- 4) Finally, my September 27, 2023 correspondence to LAFCO, detailing my inability to access the Branciforte Fire District Reorganization Protest Hearing has not been included in the Commission's October 4, 2023 meeting packet. I have copied the text of that correspondence below, and will bring hard copies for the Commissioners to review at tomorrow's meeting. i sincerely hope that other members of the public were not also prohibited from accessing the LAFCO Office, the published location for the protest ballots to be turned in "before close of the Protest Hearing."

Good Morning Ms. Becky,

The LAFCO office was open yesterday from 6am to 6pm. The blue corridor doors for the legislative wing were open yesterday. While LAFCO is not responsible for monitoring the blue corridor doors entering the legislative wing, in the event that the blue corridor doors are closed, there is a visual sign that states how to contact any of the legislative wing offices, including LAFCO, to open them. LAFCO received no calls at the time in question, including from you. That being said, you did send me an email at 9:35am about the protest hearing and the doors. I responded at 9:40am and inspected the blue corridor doors of the legislative wing, which they were open.

In summary, LAFCO did not receive any concerns/issues from any Branciforte resident or other public member (besides you) on accessing LAFCO's office, the protest hearing, or the ability to submit a petition of opposition yesterday. More importantly, LAFCO did not receive a single petition of opposition during the entire protest proceeding, including any last minute submittals yesterday (again, the LAFCO office was open until 6pm).
